# 25<sup>th</sup> Annual General Assembly – April 19 2015

# GENERAL ASSEMBLY OF MEMBERS OF THE POTTON HERITAGE ASSOCIATION HELD APRIL 19<sup>th</sup>, 2015 IN THE TOWN HALL IN MANSONVILLE

### 1 - Opening of the Meeting

Secretary Jean-Louis Bertrand determined the presence of 40 members, and therefore a quorum, according to Article 43 of the General By-laws : 10 persons physically present) ; the meeting was declared open at 10 :20 by the Association president, Sandra Jewett. She noted the presence of Mayor Louis Veillon and thanked him, in the name of the Association for the continued moral and financial support from the Municipality

## 6 - Report from Webmaster - Serge Normand

- Members :. The Association had 200 members in good standing on December 31, 2014 of which 108 or 54% were French speaking and 92, or (46%) were English speaking. 48 new members joined the Association while 34 departed.
- Web Sites : The posting on our Websites, French and English, are in constant progression : texts, photos, information. Since Novembe 2014, English and French documents posted on our sites have been downloaded more than 3,000 times. The most popular 'Owl's Head' downloaded 305 times, followed closely by 'Vale Perkins' at 283 downloads. Thanks to these sites, and to the Association, Potton's heritage is finding a wider audience.

### 8- Treasurer's report - Serge Normand

- Treasurer Serge Normand deposited the financial statements for 2014, for the Association, as prepared by Ralf Bushenbaum, Services financiers; attesting to revenues totalling \$18 049; expense of \$18 812, a deficit of \$763 and an accumulated surplus of \$5 529 as of December 31 2014. [Annex 2] Yolande Lamontagne moved, seconded by Jacqueline Robitaille and unanimously resolved to accept the financial statements for 2014 as presented.
- The Treasurer continued his report by presenting the budget forecast for 2015; wherein a balanced budget is proposed : revenues of \$14 500; expenses of \$4 500. If these figures hold, the Association will end the year 2015 with an accumulated surplus reserve of \$5 514. [Annex 3] Angèle Hébert moved, seconded by André Gagné and unanimously resolved to adopt the budget forecast for 2015 as presented.

### 9 - Remarks by Sandra Jewett

#### Our community, between belonging and isolation

Each year, tradition gives an opportunity to the President to address the general assembly about issues or projects of concern to the mission of the Association. I recognize that I stray somewhat from what duty obliges. I ask your indulgence, and I will be brief.

This winter, my thoughts have been very much taken by the negativity surrounding what I perceive as a widening gulf within our community: the deliberate actions of some, and inaction by others that seems to have allowed positions to harden among us. Dissension and division, while normal in this, or in any other community, seem to have found greater volume, while voices of reason and conciliation seem muted.

Although I cannot speak for you, I must say that I am weary of the politics of resentment and the cacophony of protest in this place I call home. I confess that I tire of the pleas of one faction over the other, while the trees we so love stand as silent sentinels to our woes. Do they see, as I do, that the vast majority among us, those in the middle, are oblivious to the views of the extremities? There is no need for me to detail the debates of the 2014-2015 season. They are etched in our minds and memory.

As an individual, I have virtually driven myself to distraction wondering how I, personally, with whatever influence I may have, could work to reverse what I see as deeply troublesome. For me to separate my duties as President of this Association from the responsibility, duty and sentiments I feel so strongly as a native citizen of Potton is very difficult. To some degree, I have been obsessed, and it has been to the detriment of my obligations as President, and for that I apologize. The Association deserves better.

Thankfully, the noise will soon subside as we proceed into the spring and summer seasons of Potton's rustic loveliness! Each of us whether barbarian or sophisticate may then enjoy the brief respite that warmer temperatures and sunshine will bring us. Problems will be out of sight but very much unforgotten. Some say the universe unfolds as it should. But I wonder?

Our views of community, rural life, and its management may differ. To be successful, the management must be sensitive to our multiple identities, values and perceptions. Someday we will learn that.

Actually, one day it might be interesting for our Association to sponsor a forum to discuss the whole philosophical spectrum of what a community is – and how to encourage positive growth within ours. Be grateful that I will not embark on that subject now.

In the interim, I intend to continue to do whatever I can to encourage the harmonious progress of our Township. I am grateful for my great good fortune to make my home here, when others, in the larger and weary world of competing sorrows, of unimaginable deprivation and displacement are so much less fortunate – where people who live in places of ancient cultures endure interminable battles over whose God is more important - whose people the most brutal – whose voice the loudest. Mothers yearn for some small modicum of peace, some crumb of hope for

their children, the majority of whom will never know the tiniest fraction of what we have and take so lightly. Food...shelter....the quiet of a starry night ... Peace!

From its founding, 25 years ago, our Association has contributed in a very positive manner to the growth of our community. I daresay even essential. We have proven by our commitment to participate in the building of a community that is more mindful of the richness of our heritage and our history. The talents and savoir-faire of our members is incredible and is such a valuable asset. Our work to promote and protect our heritage and history must continue. And we will. But, we must also continue to promote optimism and the social networking that essentially knits a community together – our community. We should each do our part, each of us in our own way.

## 10 – Perspectives 2015

The president continured by presenting the main elements of our programming for 2015:

- Exhibition of the Round Barn and guided visits, directed by Hans Walser with collaboration of the GBMP.
- Publication of HPH and of a brochure on the built heritage of commercial buildings in Potton, prepared by Jean-Louis Bertrand.
- Excursions and lectures, prepared by Carol Bishop and Janine Sourdif.
- Photography contest with themed on *Pottonites in their daily lives*.
- Participation in Potton's Multicultural Festival and operation of canteen jointly with the CKJC at the Fall Festival at Owl's Head.
- Fundraising campaign for the Round Barn in collaboration with the GBMP.

### 11 - Nomination of an Accounting firm

Treasurer Serge Normand requested the Assembly to designate Ralf Bushenbaum, services financiers, of the Township of Potton, to prepare the financial statements for 2015. Michelyne Fortin moved, seconded by Denis Lamontagne, proposed the designation of the accounting firm of Ralf Bushenbaum, services financiers, of the Township of Potton, to prepare the financial statements for the 2015 exercise. Unanimously adopted.

### **12** - Election to the Board of Directors

The Secretary of the Association, Jean-Louis Bertrand presented the slate of candidates who have agreed to their nomination. They were Jean-Louis Bertrand, Carol Bishop, Jacques Huppertz, Sandra Jewett, Serge Normand, Janine Sourdif, and Hans Walser. The Secretary confirmed that no other nominations had been received by the Association by the deadline of April 9 2015. It was moved by Sheila Kerr, seconded by Wendy Gardner, to elect those nominated to the the Board of Directors. Adopted unanimously.

### 13 – Question period

The Secretary of the assembly invited comments from the floor

- Jacqueline Robitaille suggested that the assembled congratulate the Board of Directors for their excellent work. Hearty applause ensued in obvious support of the suggestion.
- Mayor Louis Veillon noted his pride in being a member, with his wife Cheryl, of the Association. In salutation to his predecessor, former Mayor Jacques Marcoux, he reminded us that the Municipal Council has always encouraged the initiatives of the Association and will continue to do so. He noted that in order for our community to reflect that we are good neighbours, we need to get to know each other. He suggested that by introducing ourselves and fraternizing with our neighbours we could each thus enlarge our circle of friends. Our community will reflect that we are each good neighbours. He suggested that talking to each other was beneficial. He continued with the announcement that the Tourist Information Office was moving from Parc André-Gagnon to a more central location opposite Place Manson.

- Laurie Neale invites the Association to become a member of Heritage Canada. In addition to national
  recognition to the Association, membership offers many advantages. The President indicated that she would
  submit the proposal to the next regular Board meeting for discussion.
- Gérard Leduc inquired what had happened to the kiosk and the two interpretation panels that were installed at Place du Moulin, at the foot of Mill Street. Had the Municipality received any indemnity for the damages resulting from the accident ? If yes, what had been done with the sums received. Secretary Jean-Louis Bertrand noted that he will inquire from the Director general of the Municipality in order to obtain appropriate answers.

### 14- Adjournment of the Assembly

Claude Fortin moved, André Gagné seconded and it was unanimously resolved to adjourn the meeting.
